VPS Promotion Terms & Conditions

The offer is available for new and existing clients of STO, which is a trading name of AFX Capital Markets Ltd, an investment firm organized under the laws of Cyprus and regulated by the Cyprus Securities and Exchange Commission ("CySEC"), under licence number 119/10 and registration number 253014 whose registered address is 116, Arch. Kyprianou 2 & Agiou Andreou, G. Pavlides Building 3rd Floor 3601, Limassol, Cyprus.

1. The STO promotion is to provide a free VPS service to its clients that request such a service, provided that they meet the following criteria:
 - A. The client makes a minimum deposit of EUR/USD/GBP 2000 to a single STO trading account and
 - B. The Client trades a minimum volume of 5 round turn lots per month, in all of the trading accounts.
2. In case of withdrawals that bring the trading account balance below EUR/USD/GBP 1000, STO has the right to remove the VPS service OR in case the Client wishes to continue benefitting from the VPS service then the Client should pay the fee of EUR/USD/GBP 35 per month for covering the VPS cost. The Client acknowledges and agrees that the fee of EUR/USD/GBP 35 will be automatically deducted from the Client's trading account every month. Depending on when this happens during the month, the calculation method for the payment will be in accordance with the following formula:

(GBP 35 or equivalent X number of days remaining until the end of the current month, including the current day)/ (total number of days of the current month)

3. By applying for this Promotion, the Client confirms that he/she has read and agreed with the present Terms and Conditions.
4. No changes will be made to the offer, in case of losses on the account, as long as the minimum monthly trading requirement is met.
5. In case the minimum monthly trading requirement is not met, the client will be charged a EUR/USD/GBP 35 monthly fee until service cancellation.
6. In order to unsubscribe from the VPS service, the client must send an email to support@stofs.com giving a 30 days' notice of cancellation.
7. General Promotion Policy terms apply to this Promotion.
8. The Client agrees and acknowledges that STO is not responsible for any power or technical failures or any disconnection of the MT4 found on the VPS; this is a sole responsibility of the Client. In addition, the Client acknowledges that the VPS hosting is controlled by the VPS Service Provider and STO shall not be liable for any possible error, breakdown of the hosting service including communication/data failure, system errors damages, but not limited to, statutory and contingent liabilities, direct, indirect, incidental, consequential, aggravated or exemplary whether contemplated or not at the time of you entering into this agreement.
9. The Client agrees and acknowledges that STO does not provide any guarantee of the data/application etc. that is kept on the VPS and that STO does not conduct any backups or provides any service to safeguard any data/information held on the VPS.
10. Misuse of the VPS is not permitted by STO such as but not limited to sending unsolicited commercial mail, running Internet Relay Chat (IRC) Servers, Pornography and any other sexually explicit material, promoting prostitution or any other services, using hosting services in any manner that is illegal or libelous, storing or distributing materials (including software) that infringes on the owner's copyright, trademark or patent, unauthorized probing, scanning or testing the vulnerability of other systems, use of unauthorized IP addresses, interference with internet services, including attacks by mass mailing and flooding, transmission

of any material that threatens or encourages harm or destruction of any property or causes harassment of another person, activities amounting to fraud, forgery, identity fraud, or posting of defamatory, scandalous, or private information about a person without their consent.

11. The Client agrees and acknowledges that VPS is the sole responsibility of the Client and that the Client should take all necessary measures to secure and backup their own data / applications.
12. Clients will be excluded from this promotion in case they abuse the program and withdraw funds with the purpose to redeposit them again in order to participate in the said promotion. The Deposits must be new funds deposited by the Client.
13. Any material downloaded or otherwise obtained through this site, is done at the Client's own discretion and risk, and the Client accepts that he/she will be solely responsible for any and/or damage to her/his computer system, hardware, or loss of data that results from any such material.
